On May 31, 2018 the Assignment Agreement between Vermont Electric Cooperative (VEC) and Vermont Electric Power Company, Inc. (VELCO) was terminated. 220,140 Vermont Transco, LLC membership units that were purchased by VELCO on behalf of VEC in December 2014 pursuant to the agreement, were sold back to Vermont Transco, LLC.
