Dear Mrs. Hudson:

In its Order dated March 16, 2006, the Public Service Board ("Board") required Vermont Electric Power Company, Inc., ("VELCO")/ Vermont Transco, LLC¹, Green Mountain Power Corporation and the Town of Stowe Electric Department (together, the "Petitioners") to file design plans with affected parties at least one month prior to filing final design plans with the Board. As set forth in the schedule filed with the Board on April 17, 2006, that pre-review for the Middlesex substation was sent to all affected parties on May 5, 2006 and the Petitioners are, today, filing the final plans.

The following documents are included:

- Middlesex Substation One Line Diagram
- General Site Plan
- General Arrangement Plan
- General Arrangement Sections
- Aesthetic Mitigation Planting Plan
- Control House Exterior Elevation
- Grading Plan
- Foundation Plan

These plans reflect comments received from the Department of Public Service on the proposed plans. No other affected party filed comments.

¹ In Docket No. 7174, the Board approved the formation of the Vermont Transco, LLC. In the Final Order in that docket, dated June 20, 2006, the Board required Vermont Transco to file a petition to become a co-applicant and co-petitioner in this docket. Vermont Transco filed that petition on June 30 and awaits a Board decision on the matter.

Our schedule as filed on April 17, 2006, estimated that Petitioners would have an EPSC/CGP permit to file with the Board on July 7, 2006. As explained in the cover letter, that date was simply an estimate, as the Petitioners have no control over the timing of when these permits are issued. The EPSC plan was filed with the ANR in May and comments were offered and addressed. The only outstanding issue is determining a location for disposal of the soil and fractured ledge to be removed from the site. Petitioners will submit the permit to the Board as soon as it is received.
