On January 28, 2005, the Vermont Public Service Board ("Board" or "PSB") issued an Order and Certificate of Public Good ("CPG") approving Vermont Electric Power Company, Inc. ("VELCO")'s so-called Northwest Vermont Reliability Project ("Project" or "NRP"). Page 217 of the Order requires VELCO to file NRP design plans with affected parties, affected municipal governments, and municipal and regional planning commissions prior to VELCO's filing with the Board.

A tree clearing plan is not included with this submittal since the expansion area at this substation is mostly scrub-shrub, and will not involve extensive logging.


