**RE: Vermont Electric Power Company and ISO New England Inc, Docket No. ER11-2878-\_\_\_ Amendment to Filing to Correct Requested Proposed Effective Date**

Dear Secretary Bose and Deputy Secretary Davis:

Vermont Electric Power Company and ISO New England Inc.<sup>1</sup> (“ISO-NE”), as the administrator for the filing, are submitting this amendment filing to change the proposed effective date for the cancellation of the VELCO Schedule 21 (“Schedule”), in order to avoid a situation in the FERC eTariff software, which would have the cancelled Scheduled removed and then re-inserted back into the software.

On January 4, 2011, VELCO along with ISO-NE and a number of other New England Transmission Owners submitted revisions to Schedule 20, Schedule 21 and individual entity schedules. The requested date for those pending revisions in Docket No. ER11-2617 is April 1, 2011. On February 14, 2011, in Docket No. ER11-2686, VELCO submitted, through ISO-NE, a request to cancel VELCO’s Schedule 21. The requested effective date was February 14, 2011.

If FERC issues orders accepting both these filings, VELCO’s Schedule would be removed from FERC’s eTariff database effective February 14, 2011, but then be re-inserted on April 1, 2011. In order to avoid this error, VELCO is amending its filing to change the requested effective date for cancellation of the Schedule to April 1, 2011.
