On May 31, 2018 the Assignment Agreement between Vermont Electric Cooperative (VEC) and Vermont Electric Power Company, Inc. (VELCO) was terminated. 220,140 Vermont Transco, LLC membership units that were purchased by VELCO on behalf of VEC in December 2014 pursuant to the agreement, were sold back to Vermont Transco, LLC.

13. On April 5, 2018 the Board accepted Christine Hallquists' resignation and appointed Michael Bursell to the Board of Directors.

On June 7, 2018 John Flynn was elected to fill the position of Vice Preseident of Strategic Business Development.

On July 15, 2018 the Board accepted Neale Lunderville's resignation.

On September 13, 2018 the Board appointed James Gibbons to the Board of Directors.

On September 30, 2018 Vermont Transco LLC sold 96,862 Class A Membership Units and 123,278 Class B Membership Units to Vermont Electric Cooperative.
