I've had a chance to review this. No work is being done in the highway right-of-way and therefore no permit is needed. I recall some work at or around this access a few years back too! Also, because there is no DRB or ACT250 approval, no jurisdictional Opinion (JO) is required. But if either the PUC or the Town of New Haven need something from VTrans I can certainly write a JO. The traffic from this will not justify a Traffic Impact Study either.
