Ms. Stevens shared how our system operators continue to reliably operate the VELCO system during the advancing energy transformation despite not having visibility into the increasing number of connected distributed energy resources (DERs). Mr. Presume discussed how DERs play a role in transmission planning and the ISO-NE Pilot study. The planners need solar data to ensure that their studies model reality including the amount of distributed generation. It would be helpful for the developers to provide that information. Mr. Kopin shared the emerging requirements from FERC and NERC. Mr. Owyang discussed the visibility and the ask from VELCO to the distribution utilities that may come in the future.

Ms. Stevens provided an operations update including the spring load trend, Vermont's export of power in May, a geomagnetic disturbance that took place on April 23rd, and an overall activity update.
