VELCO Operating Committee Meeting Minutes Thursday, January 15, 2009

The Operating Committee meeting for Vermont Electric Power Company, Incorporated was held at VELCO, 366 Pinnacle Ridge Road, Rutland, Vermont and was called to order by the Chairman, Neal Robinson, at 11:08a.m.

By motion duly made by Ken Mason and seconded by Don Rendall, the minutes of the December 18, 2008 meeting were approved as submitted.

Discussed revision protocol to V-TAM. They were approved with the exception of moving bullet four to become the second bullet. It was decided that when a DU submits a proposed change they will submit it as an agenda item. If they do not wish to have it as an agenda item they may submit a redline version, which will then be posted to the website.

SPA Draft

- Neal Robinson handed out an illustration comparing O&M allocation under the current V-TAM wording and under the proposed SPA.
- Committee discussed with Dave Coleman
- Neal Robinson is to go back to Richard Lorenzo and ask that SPA be revised only in respect to cost allocation, which should be changed from per capita to asset based allocation.

Definition of Exclusive Facilities

- Dave Coleman reviewed his proposed change to the V-TAM definition
- After discussion Dave was asked to expand the definition
- Dave will edit and forward to Neal for clarification

VELCO Long Range Planning

- Greg White distributed a suggested "Affected Utility" criteria
- After discussion it was agreed that Greg would modify the criteria and forward to Frank Ettori. Frank will then apply the criteria to the projects in the Long Range Plan. The revised listing will be circulated for review but will be submitted to the VSPC. There

will be an effort to solicit input from DU's and resolve any disagreements prior to a VSPC vote in February.

IGAP Credit

- Thad Omand reviewed his proposal interpretation of the IGAP definition and application.
- Significant discussion surrounding the IGAP credit definition and the intent of the language used.
